Could Ligonier Become Penn Township?

- Penn Township has dry gas. Ligonier has dry gas.
- Mr. Korns is the solicitor advising supervisors on the gas ordinance for Penn Twp.

 Mr. Korns is the solicitor advising supervisors on the gas ordinance for Ligonier Twp.
- Many residents of Penn Twp. thought fracking would never affect them. They have dry gas and are very much built out with housing developments.
 Many residents of Ligonier think fracking will never affect them. Ligonier has dry gas and is a beautiful, rural tourist area.
- Penn Twp supervisors changed residential districts by overlaying a gas extraction area to allow for fracking.
 Ligonier Twp supervisors changed much of the residential/conservation districts to agriculture to allow for fracking.

But.... the industrialization of Penn Twp. has begun

- At the PT Gaia site, where 9 wells are planned, the industrial development will be a 50- year expected activity.
- According to residents, the company doesn't disclose the extent of their plans; they will inform the Board of plans for 5 wells at a pad, but can have double that number planned for. So, it is hard to know the exact total number of wells proposed. There could be 70 to 100 wells planned for Penn Township.
- Penn Twp is only 30 square miles.

Consequently, Penn Twp. residents have had to mount legal challenges

- Protect PT is simultaneously challenging 11 different permits at the local, county and state levels.
- In April, Protect PT began its challenge of the Penn Township Mineral Extraction Overlay District at the Westmoreland County Court of Common Pleas.
- Protect PT filed an appeal with the Environmental Hearing Board, challenging the DEP's issuance of two permits to Apex Energy (PA), LLC for the Drakulic well pad.
- Protect PT filed four appeals on the Drakulic, Deutsch, Backus and Numis Well Sites all within a mile of Level Green Elementary School. This case is appealed to the Commonwealth Court.

We hope we never have to face the industrialization that Penn Township residents must now deal with. To protect the Valley, Ligonier Twp. must put protective zoning in place now, before drilling starts.
